MAPLERIDGE RANCH SUMMER CAMP AGREEMENT

This agreement is made by and between Haven of Peace, Inc., d/b/a Mapleridge Ranch ("MAPLERIDGE"), 2857 Montrose Turnpike, Owego, New York and the parent(s) and/or guardian(s) who sign below on behalf of their children.

In consideration of the mutual promises stated herein and other good and valuable consideration provided for herein, the parties hereto agree:

AUTHORIZATION TO PARTICIPATE IN SUMMER CAMP ACTIVITIES

By signing below, I authorize my child or children whose names are listed below to participate in all summer camp activities. Summer camp activities include but are not limited to horseback riding, climbing tower, paintball (age 11 and above), overnight campouts, swimming (provided child or children pass swimming test) and other activities.

I acknowledge that all summer camp activities involve some risk of injury or death to my child or children.

ACKNOWLEDGEMENT OF DOCTRINAL STATEMENT AND BELIEF

I acknowledge and understand **MAPLERIDGE** will not permit any camper or parent <u>advocating</u> or <u>engaging</u> in beliefs and/or practices at camp that conflict with **MAPLERIDGE**'s evangelical faith and/or moral teachings as outlined in their Doctrinal Statement and discussed in detail in the Holy Bible, and/or with their Camp Code of Conduct.

By signing below, I acknowledge that in good faith I and my child/ren will abide by the Camp Code of Conduct at all times while at camp and that I and my child/ren will respect their evangelical faith and moral teachings.

SPECIAL AUTHORIZATION FOR HORSEBACK RIDING (HB)

Horses are one of the most majestic and beautiful parts of God's creation. They are a wondering part of the summer camp experience at **MAPLERIDGE**. However, horses are inherently dangerous and must be approached and handled with care. At all times, the directions and instructions of designated riding instructors and camp rules about horses will be followed.

I acknowledge and agree with the paragraph above. By initialing below, I authorize my child or children to participate in horseback riding at **MAPLERIDGE**.

SPECIAL AUTHORIZATION FOR PAINTBALL (PB)

Paintball is an inherently dangerous activity. It is also a lot of fun and a wonderful part of the summer camp experience at **MAPLERIDGE**. Due to the nature of paintball, we limit participation to children ages eleven and older.

I acknowledge and agree with the paragraph above. By initialing below, I authorize my child or children to participate in paintball at **MAPLERIDGE**.

AUTHORIZATION TO PROVIDE NECESSARY MEDICAL CARE

I authorize personnel of **MAPLERIDGE** to provide necessary medical care to my child or children in the event the need arises. Such care may include but is not limited to performing physical examinations, performing or order x-rays, CT scans, MRI's or other diagnostic testing, dispensing over the counter analgesics and other medications. I hereby waive my right to object to any necessary medical care performed on my child or children at **MAPLERIDGE**.

MAPLERIDGE RANCH SUMMER CAMP AGREEMENT

I authorize personnel of **MAPLERIDGE** to hospitalize my child or children in the event of a medical emergency if the circumstances warrant it or I cannot be reached by telephone. I acknowledge that hospital care may include physical examinations, performing or order x-rays, CT scans, MRI's or other diagnostic testing, vaccinations or other injections, anesthesia and emergency surgery. While I acknowledge that attempts will be made to reach me in the event of a medical emergency, I hereby waive my right to object to any of the medical procedures performed on my child or children pursuant to this paragraph.

I acknowledge **that I shall be financially responsible** for the cost of any medical care given to my child during his or her time at **MAPLERIDGE** or as a result of activities at **MAPLERIDGE**. My medical insurance shall be the insurance coverage applied to any medical treatment. I shall be responsible for all co-pays and/or deductibles.

SPECIAL AUTHORIZATION TO APPLY SUNSCREEN

By initialing below, I authorize personnel of **MAPLERIDGE** of the same gender as my child to administer sunscreen when help is needed. (SS)

LEGAL REPRESENTATIONS, WARRANTIES & COVENANTS

I represent that I am the biological parent or lawful guardian of the child or children whose names are listed below. I represent that I have full legal authority to enter into binding agreements on their behalf without need of any other person's authorization.

I represent that my child or children has received all mandatory vaccinations as required by New York state law or Pennsylvania state law or the applicable state law of my residence OR that I have informed the Executive Director of **MAPLERIDGE** that my child's vaccination record is incomplete.

I warrant that my child's or children's participation in summer camp at **MAPLERIDGE** is voluntary.

I warrant that my child is physically and mentally fit to participate in summer camp at **MAPLERIDGE** as described above.

I covenant to abide by the **MAPLERIDGE** Visitation Policy, which prohibits parents or guardians from visiting **MAPLERIDGE** in the middle of a camp session and only permits parents or guardians to pick up their child due to a medical emergency or family emergency without forfeiting the remainder of the camp fee.

MAPLERIDGE covenants to limit the use of any photographs, videos or other images taken of your children to promotional purposes for the camp.

I waive, on behalf of myself and my child or children, any right we have in photographs or other images taken by others of my child or children.

RELEASE FROM LIABILITY & INDEMNIFICATION CLAUSE

I hereby release, on behalf of myself and my child or children, and forever hold harmless **MAPLERIDGE**, its officers, directors, employees, agents, contractors, volunteers and affiliates, representatives, insurers, successors and assigns from any and all claims or demands for personal injury, illness, death, loss of personal property, property damage and expenses, of any nature whatsoever, incurred by my child or children, except to the extent caused by gross negligence or willful misconduct of personnel of **MAPLERIDGE**.

MAPLERIDGE RANCH SUMMER CAMP AGREEMENT

I shall indemnify **MAPLERIDGE** from any and all claims and demands for personal injury, illness or death as well as property damage and expenses of any nature whatsoever incurred by my child or children, except where the same was caused by gross negligence or willful misconduct of personnel of **MAPLERIDGE**.

ARBITRATION AGREEMENT

Any dispute arising out of or in connection with or in relation to this agreement and/or summer camp activities shall be resolved by binding arbitration under the most recent rules of the American Arbitration Association. The seat of the arbitration shall be Owego, New York.

FINANCIAL TERMS

REFUND OF PAYMENTS: Registration fee is non-refundable. A cancellation of pre-paid camp fees made after May 1st, will receive no refund, but will receive a camp credit for another week of camp or other camp program. We make no allowances for campers arriving late. If a camper should leave camp before the end of their enrolled session for any reason other than illness, the camp shall apply one-half of the prorated camp tuition toward next year's fee.

PAYMENT SCHEDULE: Unless you have paid in full at time of registration, you must choose a Monthly or Payment Installment Plan at time of registration. All fees are due by June 16, prior to your child's arrival to camp.

GOVERNING LAW

This agreement shall be governed by the laws of the State of New York exclusive of its conflict of law provisions.

ENTIRE AGREEMENT

This Agreement represents the entire agreement between myself, my child or children and **MAPLERIDGE** and it supersedes all prior agreements oral and written between the parties. This Agreement may only be modified in a writing signed by both parties.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ AND UNDERSTAND THIS AGREEMENT. I HAVE HAD THE OPPORTUNITY TO SEEK AN ATTORNEY'S COUNSEL AND HAVE DONE SO OR HEREBY WAIVE MY RIGHT TO THE SAME. I ACKNOWLEDGE THAT BY SIGNING THIS AGREEMENT I AM FREELY GIVING UP SUBSTANTIAL RIGHTS IN EXCHANGE FOR MY CHILD OR CHILDREN PARTICIPATING IN SUMMER CAMP AT MAPLERIDGE.
